IN ADDITION TO THE PARTNER FAMILIES THAT PURCHASED HABITAT HOMES THIS FISCAL YEAR, THE HOMEOWNERSHIP CENTER ALSO HELPED TWO FAMILIES ACHIEVE HOMEOWNERSHIP USING OTHER AFFORDABLE MORTGAGE PRODUCTS. IN JUNE 2020, THE ST. TAMMANY HOMEOWNERSHIP CENTER WAS APPROVED AS A HUD LOCAL HOUSING COUNSELING AGENCY, CURRENTLY THE ONLY SUCH APPROVED AGENCY IN ST. TAMMANY PARISH.
